INTERNATIONAL JOURNAL OF BODY COMPOSITION RESEARCH (IJBCR) AUTHORS' GUIDELINES

Scope of the journal/editorial policy

IJBCR is a peer-reviewed journal offering early publication of original research reports, short communications, review articles (please contact the editor prior to submission to determine suitability), and letters to the editor (<500 words). IJBCR aims to promote knowledge and development and to stimulate knowledge-based discussion. Contributions are welcome on all relevant aspects of physics and methodology, biology, medicine and public health, and appropriate studies in animals and animal sciences. For further information contact the editors (below).

Conditions of publication

Papers are accepted for publication on the understanding that the content is original, has not been published and has not been – nor will be, while under offer – submitted elsewhere. The submitting author warrants that all authors are in agreement and responsible for publication. The authors are responsible for obtaining permission for the re-use of any copyright material. Copyright is transferred to the publisher upon publication. Note that the publisher does not require the author to request permission for use of individual items (eg figures) elsewhere but does require acknowledgement of the journal. Authors may copy the paper for their own teaching use.

Ethics and informed consent

All studies reporting experiment with animals should state approval by an institutional or regional Animal Care and Use Committee. Human studies must be in accordance with either the Helsinke Declaration of 1975 (as revised in 2000) or be in accordance with the institutional or regional ethical standards of the responsible committee. Institutional Review Board approval should be stated

Authorship and contributors

IJBCR follows the guidelines established by the International Committee of Medical Journal Editors with respect to authorship and contributors (http://www.icmje.org/#author).

Conflicts of interest

JJBCR follows the guidelines established by the International Committee of Medical Journal Editors with regard to conflicts of interest (http://www.icmje.org/#conflicts).

Submission of papers for publication

Papers should be sent electronically to the editor (tnagy@uab.edu), preferably in MS Word format. All tables and figures (see below) should follow the text as part of the same document as the text proper.

Main text features and style

The presentation of the paper should follow that of scientific journals eg as to the normal section headings and type layout (A4 etc) and the Vancouver style. IJBCR will observe both US and UK spelling and authors should be consistent with either Merriam-Webster's Collegiate Dictionary or editions of the Oxford Dictionary (please note the verb ending -ize is preferred, and both unnecessary capital letters and stops are avoided, thus government not Government, eg not e.g.). Use SI units where possible. Do not hesitate to explain units that may not be familiar to all readers (especially if non-SI). Spell out abbreviations only at first use in text.

Take care to use and explain all use of trade names or products. Quantities when not used with standard units such as g, mm should be spelled out in text from one to ten and thereafter take the form 11, 117, 1117 and 11 117 (note spacing and absence of stops). Use italic and bold type only in exceptional cases and eg not for foreign words.

Title page

Give title of paper (fully informative but concise); first name, middle initial, and last name, without degrees of all authors: institutional affiliations of all authors; and contact information for the corresponding author.

Abstract and key words

The abstract should be concise (<250 words) and self-contained (no reference to the text or citations). Each abstract will have the following sections: Objective; Research Methods and Procedures; Results; Discussion. List up to 5 key words not found in the title.

References

Cite in numerical order in text inside square brackets, eg [1, 17-24, 77] within the text not outside the relevant sentence. List references by number at end of text (more than three authors may be cited as Jones, Howe, Lee et al.). Unpublished and personal references appear only in text. Do not use italics or bold type and follow the punctuation style below eg in author listing.

For journals use:

Tables

Tables should be set out on separate pages, with their title above, and numbered in sequence in which they appear (Table 1, 2 etc).

Do not duplicate text. Place supporting information in title. Define units in footnotes using a,b,c, Use * ** for probability.

Figures

Small figures should fit within one column (< 8cm) and large figures must fit within two columns (< 16.7cm). It is suggested that figures be sized by the author prior to first submission (300 dpi minimum). Color figures are not accepted at this time. Use a font for lettering which is widely used (so that it can be edited in case of need) and sizes compatible with the design of the artwork. However note that Figures will not be redrawn.

Proofs, offprints and page charges

Proofs will be sent to the corresponding author electronically as a PDF file, together with an order-form for offprints. There are no page charges at this time.
